Interested Bidders shall provide their Bids, with required documents, demonstrating that they have the required qualifications, financial soundness and relevant experience to provide the above-mentioned items/services. ‘**Single Stage Two Envelope**’ bidding procedure, shall be adopted as per PPR Rules, 2014. The bid must be accompanied with Bid Security of **Rs. 63,000/- (Approx. 2%)** to be attached with Technical Bid in the form of Bank Guarantee/Demand Draft/CDR/Pay Order, in favor of Multan Waste Management Company. The Bid Security is as per PPR Rule # 27 which states that “*The procuring agency may require the bidders to furnish a bid security not exceeding five percent of the estimated price*”. The Bids, without Bid Security, shall be rejected being non-responsive.
