Late bids will be rejected. Bids of only those bidders will be entertained who purchased the tender document.

Interested Bidders shall provide their Bids, with required documents, demonstrating that they have the required qualifications, financial soundness and relevant experience to provide the above-mentioned items/services. ‘**Single Stage Two Envelope**’ bidding procedure, shall be adopted as per PPRA Rules, 2014. The bid must be accompanied with Bid Security of Rs. 20,000/- (Approx. 2%) to be attached with Technical Bid in the form of Bank Guarantee/Demand Draft/CDR/Pay Order, in favor of Multan Waste Management Company. The Bid Security is as per PPRA Rule # 27 which states that “*The procuring agency may require the bidders to furnish a bid security not exceeding five per cent of the estimated price*”. The Bids, without Bid Security, shall be rejected being non-responsive.

The bids must be received by **11:30 hours** in the office of MWMC by registered post/courier or delivered in person on or before **6th APR 2023**. The Bids will be opened on the **same date** at **12:00 hours** at the below mentioned address in the presence of bidders or their authorized representatives who choose to attend, with their original CNICs.
