'Single Stage Two Envelope' bidding procedure, shall be adopted as per PPRA Rules, 2014. The bid must be accompanied with Bid Security of Rs. 140,000/- (Approx. 2%) to be attached with Technical Bid in the form of Bank Guarantee/Demand Draft/CDR/Pay Order, in favor of Multan Waste Management Company.
