Interested Bidders shall provide their Bids, with required documents, demonstrating that they have the required qualifications, financial soundness and relevant experience to provide the above-mentioned items/services. 'Single Stage Two Envelope' bidding procedure, shall be adopted as per PPRA Rules, 2014. The bid must be accompanied with Bid Security of Rs. Rs.700,000/-(Approx. 2%) to be attached with Technical Bid in the form of Bank Guarantee/Demand Draft/CDR/Pay Order, in favor of Multan Waste Management Company. The Bid Security is as per PPRA Rule # 27 which states that "The procuring agency may require the bidders to furnish a bid security not exceeding five per cent of the estimated price". The Bids, without Bid Security, shall be rejected being non-responsive.
