Interested Bidders shall provide their Bids, with required documents, demonstrating that they have the required qualifications, financial soundness and relevant experience to provide the above-mentioned items/services. ‘**Single Stage Two Envelope**’ bidding procedure, shall be adopted as per PPRA Rules, 2014. The bid must be accompanied with Bid Security to be attached with Bid in the form of Bank Guarantee/Demand Draft/CDR/Pay Order, in favor of Multan Waste Management Company. The Bid Security is as per PPRA Rule # 27 which states that “*The procuring agency may require the bidders to furnish a bid security not exceeding five per cent of the estimated price*”. The Bids, without Bid Security, shall be rejected being non-responsive.

The bids must be received by **12:30 hours** in the office of MWMC by registered post/courier or delivered in person on or before **27<sup>th</sup> Sep 2022 (Tuesday)**.
